What the credit reference agencies will do:

- a) Whether or not your application proceeds, credit reference agencies will place on your credit file a record of our search. This includes searches of principal directors. The record of that search will NOT be seen by other organisations when you apply for credit in the future. A large number of applications within a short period of time could affect your ability to obtain credit.
- b) The agencies may supply to us credit information such as previous applications and the conduct of accounts in your name and of your financial associate(s) and any business accounts you have, public information such as County Court Judgements and bankruptcies and Electoral Register information, and fraud prevention information.
- c) Occasional searches may be carried out throughout the duration of your agreement where required, to ensure the conduct of the account.
